**Community engagement event sub-group**

A local resident, Judith Proctor, is able to assist residents with lowering their carbon footprint, and it was agreed to invite her to the event, possibly to speak. The Clerk agreed to contact her.*

*John and the rest of the sub-group will continue to plan the event with assistance from the Clerk.*

**Reducing the Council's carbon footprint sub-group**

*Cllr Holland reported that the sub-group had looked at all areas of the Council and had come up with a list of ideas of how the Council could reduce its carbon footprint and had also looked at projects such as setting up a solar farm. Assistance is available from Low Carbon Dorset and since the sub-group had met John Van Breda had attended one of its events where spreadsheets for preparation of an energy audit had been provided, so the Sub-Group will now progress this.*

*John Van Breda thought it important for the Council to set a date for it to become carbon neutral.*
